Chief of Outreach & Community Relations New Jersey Division on Civil Rights

Dr. Denalerie Johnson-Faniel, has twenty years of public education, learning and development, DEI, mental health, human resources and community relations experience. A Garden State Global Non-Profit Woman of the Year, Network Business Journal Top 40 Under 40 and a YWCA Woman of the Year honoree, she was the international executive vice president of workforce development at Dress for Success Worldwide.

Dr. Johnson-Faniel also served as director of organizational development and change management

at Jewish Home and Hospital Life Care; was director of national operations at the Gay, Lesbian and Straight Education Network and led as president and CEO of a National Urban League affiliate.

As director of a New Jersey Feeding America food bank, her team revitalized the agency into a health equity modeled countywide nutritional health and wellness impact center. She has managed government, K-12/higher education, corporate, community and nonprofit anti-bias training and was the national mentoring consultant for the Center for Supportive Schools.

Dr. Johnson-Faniel is Lean Six Sigma HR Greenbelt certified, DEI and mediation and arbitration certified and founded 3D Management Consulting, LLC, a national boutique firm. She is also a certified yoga instructor, Reiki master, holistic life coach, autism behavioral analyst, and gender studies, history, contemporary problems, sociology, psychology and multi-culturalism adjunct professor.

The board-certified human services professional has held elected and appointed government roles, she sat on the Edison-Metuchen NAACP board of directors; her local human relations commission, served as an advisory committee member of the Anti-Poverty Network of New Jersey; held Zeta Phi Beta Sorority, Inc.'s international social action co-director role and chaired their New Jersey advocacy and youth and civil rights partnerships teams.

Dr. Denalerie Johnson-Faniel a MPH student at TCNJ, has a PhD in human services public leadership and non-profit management, an Ed.M. in psychological counseling, an MA in organizational psychology and human resources and a BS in psychology and business management and BA in Afro-American studies and political science. #### **Lora** Fong

Assistant Attorney General, Keynote Speaker

Lora Fong is an Assistant Attorney General and serves as the Chief Diversity, Equity, & Inclusion Officer for the Department of Law and Public Safety, responsible for developing and implementing the agency's strategic diversity and inclusion initiatives.

Before joining the department in 2016, Ms. Fong practiced law both in private practice law firms and as in-house counsel in multi-national corporations. She also has served as the general counsel of an entrepreneurial

multi-media company and as a consultant to members of the Fortune 500 on diversity, equity, and inclusion

Ms. Fong has been recognized as a Distinguished Leader of the Bar by the New Jersey Law Journal, was awarded the Mel Narol Excellence in Diversity Award by the New Jersey Bar Association, and received the Professional Achievement Award from the Asian Pacific American Lawyers Association of New Jersey. Additionally, she was the inaugural recipient of the Distinguished Alumni Award conferred by the Rutgers Law School Minority Student Program. Her pro bono and community activities include service as a member of the NJ State Advisory Committee to the U.S. Commission on Civil Rights, counsel to the Organization of Chinese Americans-NJ Chapter, and counsel to the Women's Political Caucus of New Jersey. Additionally, Ms. Fong has served as a Trustee of the New Jersey State Bar Association and co-chaired its Diversity Committee. She is a past President of the Asian Pacific American Lawyers Association of New Jersey and member of its Advisory Board. Currently, she serves as a Director of the New Jersey Women Lawyers Association. Ms. Fong has been a member of the Rutgers Board of Governors as well as the Rutgers Board of Trustees.

Ms. Fong earned a B.A. in Political Science and a Certificate in Women's Studies from Douglass College at Rutgers University, and a J.D. from Rutgers University School of Law in Newark. She is admitted to the bar in New Jersey, New York and various federal courts.

He graduated from Rutgers University with a Bachelor of Arts degree in Political Science/History, and is pursuing his master's in public administration (MPA) and National Security at the American Military University (AMU).

He has served in the United States Air Force as an enlisted member and Intelligence Officer and is fluent in Urdu, Punjabi and Hindi.

## David S. Leonardis

Captain, NJ State Police (Retired)

Dave Leonardis is the Training & Outreach Liaison for the Office of the Attorney General, Division of Criminal Justice, Prosecutors Supervision & Training Bureau. In that role, he is responsible for specialized training for law enforcement officers, as directed by the Attorney General and the Director of the New Jersey Division of Criminal Justice. His duties also include law enforcement and community outreach for the State of New Jersey. Dave works with law enforcement and government agencies, as well as community and faith based organizations in order to enhance community relations on a local

and State level. Mr. Leonardis received the 2019 Community Outreach Award for the Division of Criminal Justice from Governor Phil Murphy and the 2019 Attorney General's Award for Outstanding Contribution to a Special Project. Dave currently is also the State Chief Resiliency Officer for New Jersey, overseeing the New Jersey State Law Enforcement Resiliency Program. He holds the title of Vice-President for the New Jersey Bias Crimes Officers Association and delivers Bias Awareness training to members of the community and law enforcement throughout New Jersey. In addition, he oversees the DELTA Leadership Course for the State of New Jersey.

Dave was the Chief for the Outreach and Special Projects Bureau at the New Jersey Office of Homeland Security & Preparedness (OHSP). He was responsible for overseeing special projects and developing private sector outreach programs. In that role, he has developed statewide outreach programs and partnerships with operators of malls, sports/entertainment venues, hotels, casinos, airports, motor coach, motor truck, taxi, limousines associations, correctional facilities, military bases and faith based groups. He helped implement the NJ Interfaith Advisory Council for OHSP. For his outreach efforts, he received the 2011 Law Enforcement Officer of the Year Award from the NJ Retail Merchants Association and NJ Food Council, the Peace Island Institute (Turkish-Muslim organization) Government Achievement Award in 2012 and the Attorney General's Award for Excellence in Public Outreach in 2013.

Prior to being the Chief for Outreach and Special Projects, he was the OHSP Training Bureau Chief, responsible for development and delivery of counter-terrorism and domestic preparedness training programs. Prior to that position, he was the Chairman of the Domestic Security Preparedness Planning Group, which was part of the Domestic Security Preparedness Task Force, under the Office of the Attorney General. The Planning Group was responsible for developing homeland security plans for the State of New Jersey.

Dave served 29 years with the New Jersey State Police before retiring at the rank of Captain and the Executive Officer of the Investigations Section. Dave had a variety of criminal investigation assignments during his career with State Police, including Narcotics, Organized Crime, Arson, Cargo Theft & Robbery, Official Corruption and others. He was cited for his work involving terrorism-related cases that received national attention: the Brinks Armored Car Robbery in Nyack, New York, where four police officers, security guards were killed by members of the Weathermen Underground and the Black Liberation Army. He was also cited for his work on the Trooper Lamonaco homicide

investigation and the capture of members of the United Freedom Front, a domestic terrorist group responsible for Tpr. Lamonaco's death. The United Freedom Front were on the Federal Bureau of Investigation's Ten Most Wanted List for a series of bombings and bank robberies that occurred prior to and after the murder of Trooper Lamonaco. All members of the group were captured in what turned out to be the largest manhunt since the Lindbergh kidnapping.

Dave served as the Commandant of the New Jersey State Police Training Academy where he received the "Team/Partnership Achievement Award" from Acting Governor Donald DiFrancesco, the Meritorious Award from New Jersey State Police Superintendent Carson Dunbar and the "Employee Recognition Award" from Attorney General John Farmer for his work in re engineering the Academy's curriculum and in-service training program. He was cited by the federal monitors overseeing the Consent Decree on Racial Profiling for his part in designing a training plan to develop a positive organizational culture and structure.

Mr. Leonardis received a B.S. from William Paterson College and a Master's Degree in General Education from Seton Hall University. He was an adjunct professor in the Criminology Department at The College of New Jersey, and taught at Seton Hall University's Education and Human Resource Departments and currently teaches in the Monmouth University Criminal Justice Graduate program.



### **Harpreet** Singh Mokha

National Program Manager

Harpreet Singh Mokha serves as the National Program Manager on issues regarding the Muslim, Arab, Sikh, South Asian and Hindu (MASSAH) communities at the Community Relations Service (CRS), U.S. Department of Justice. Harpreet works with law enforcement, government, civil rights groups, faith-based groups, and other community organizations across the country to share information and foster dialogues on ways to prevent and respond to alleged hate crimes against MASSAH communities.

Prior to this role, Harpreet had served as the Mid-Atlantic Regional Director for CRS for seven years, where he has worked with law enforcement, federal, state and local government officials, community leaders, and federal agencies to provide support in addressing tensions associated with allegations of discrimination on the basis of race, color, and national origin.

His work includes helping communities develop resources to effectively prevent and respond to violent hate crimes committed on the basis of actual or perceived race, color, national origin, gender, gender identity, sexual orientation, religion, or disability. Additionally, Harpreet has worked closely with law enforcement and community leaders to conduct trainings, design and facilitate dialogues, and identify opportunities to increase community engagement.

Harpreet joined CRS at the Department of Justice after serving as a civil rights attorney and the Legal Director of UNITED SIKHS in Washington, D.C. As Legal Director, Harpreet was involved in numerous outreach initiatives, served to create cultural programs, and conducted educational seminars with federal, state, and local government agencies to increase awareness of issues faced by the Sikh American community. He has extensive experience in providing legal guidance and counseling on issues such as civil rights and liberties violations, post 9/11 backlash, airport profiling, employment discrimination, and immigration law.

Harpreet earned his Juris Doctor from Michigan State University College of Law and Bachelor's degrees in Finance and Human Resource Management from the University of Houston.

Jessica C. Kim, LCSW, CCTP is a licensed clinical social worker and certified clinical trauma professional with 20 years of experience in agency, school, government, and private practice settings delivering clinical services to youth, adults, and families. As a current PhD student of social welfare at the University of Pennsylvania School of Social Policy and Practice, her research is committed to centering perspectives of Asian American communities in understanding their own mental health needs. She believes in exploring ways to critically re-imagine culturally situated systems of care.

She is a nationally sought-after speaker on Asian American mental health issues. Her recent works include <u>"A Call to Healing Asian Racialized Trauma"</u>, <u>"From Disparities to Progress: Cultural Reflexivity in Framing Asian American Mental Health Research"</u>, and a co-authored book chapter, <u>"Pathways to Mental Health Service Use for Korean American Adolescents: A Case Study" in the first book focused solely on Korean American mental health.</u>


# Lubna Qazi-Chowdhry Legal Specialist
