**NUMBER OF POSITIONS AVAILABLE:** One (1) - Location preference required.

<u>DUTIES:</u> Under the direction of the Executive Director, Director, or other supervisory official in the Office of Public Integrity and Accountability, assists in the management and oversight of the Special Investigations Bureau, providing legal advice and guidance on criminal-justice matters of a complex nature with statewide significance. Interprets and enforces laws, regulations and other official instrumentalities; performs extensive research and writing on complex legal issues; and supervises teams of investigators, analysts, and prosecutors in the investigation and prosecution of criminal and other improper conduct. Works on statewide initiatives and priority projects, and performs other related duties as assigned or required. This position may also require non-traditional work hours, on an as needed basis, including evenings and weekends on short deadlines for certain assignments, with or without advance notice, and may require travel to perform the aforementioned responsibilities.

## **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

**EXPERIENCE:** Five (5) years of experience as a practicing attorney, two (2) years of which shall have been in a supervisory capacity.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**PREFERENCE:** Preference will be given to candidates with experience in criminal prosecutions and internal affairs investigations, past supervisory experience over legal and investigative staff; demonstrated ability to multi-task and work effectively with a broad cross-section of stakeholders; and excellent written and oral advocacy skills.

<u>SAME APPLICANTS:</u> If you are applying under the NJ "SAME" program, your Schedule A or B letter must be submitted along with your resume and any other required supporting documents indicated on the announcement by the closing date indicated below. **RESUME NOTE:** Eligibility determinations for experience and education will be based upon the resume, employment application, including required supporting documents (JD transcripts). Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide a CSC approved evaluation indicating the U.S. equivalency, with a course-by-course breakdown, prior to the closing date (see <u>CSC foreign degree information</u>). Failure to do so may result in disqualification of your education towards eligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
