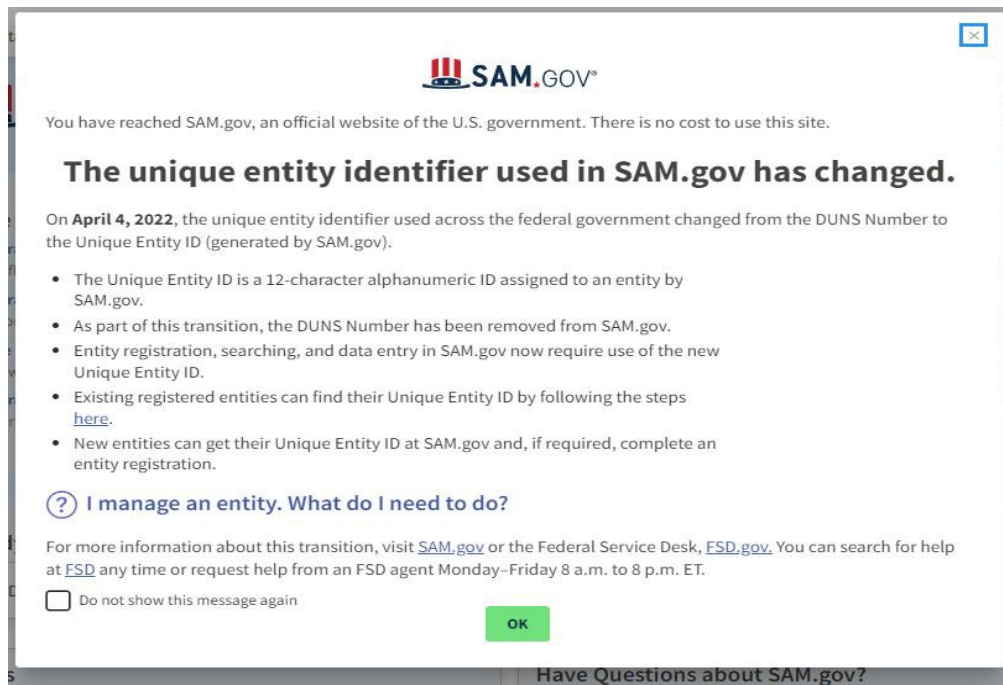
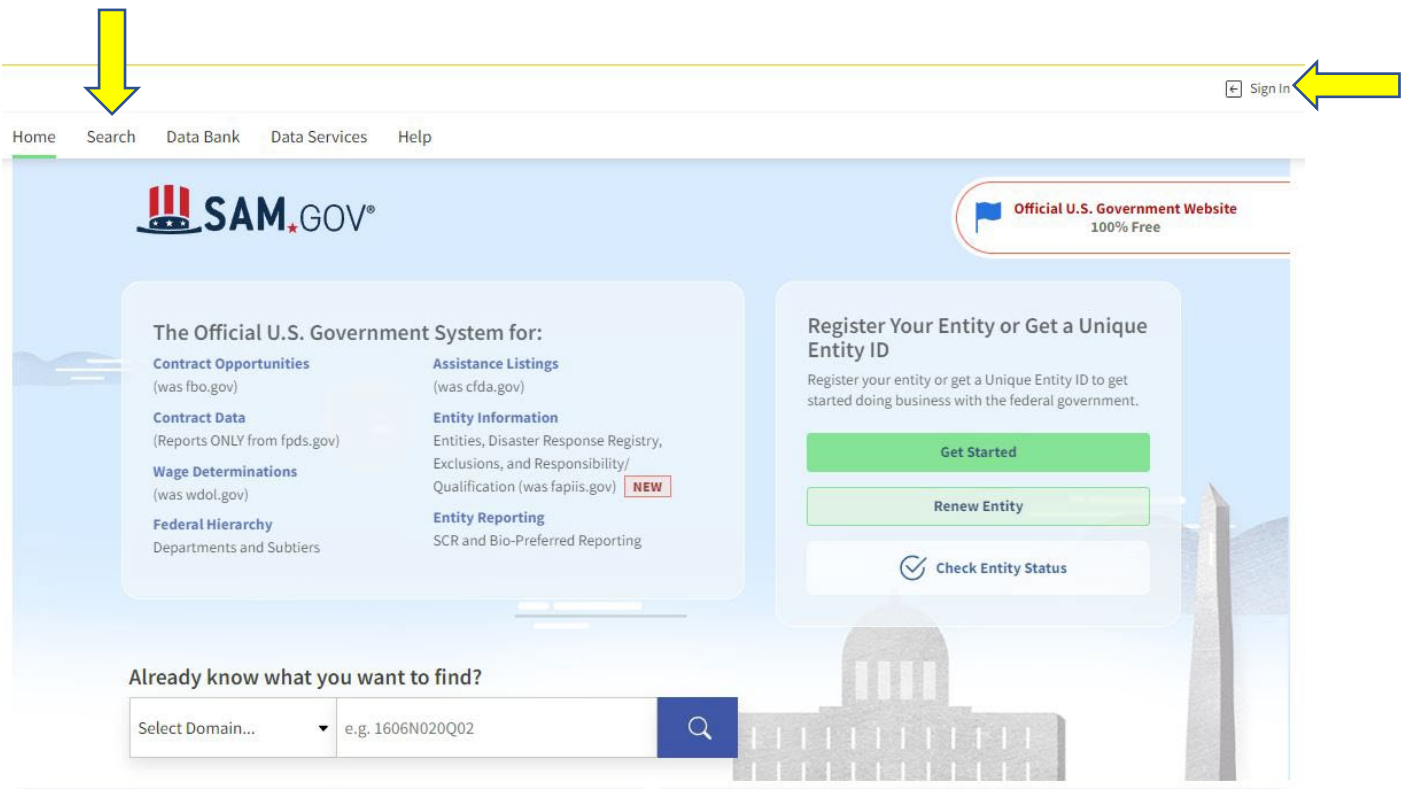


# HOW TO SUBMIT PROOF OF ELIGIBILITY TO RECEIVE FEDERAL FUNDS

In order to complete the Department of Law & Public Safety Debarment and Suspension Certification, you must access <https://www.sam.gov> and print out proof of eligibility to receive federal funds.

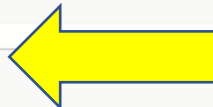

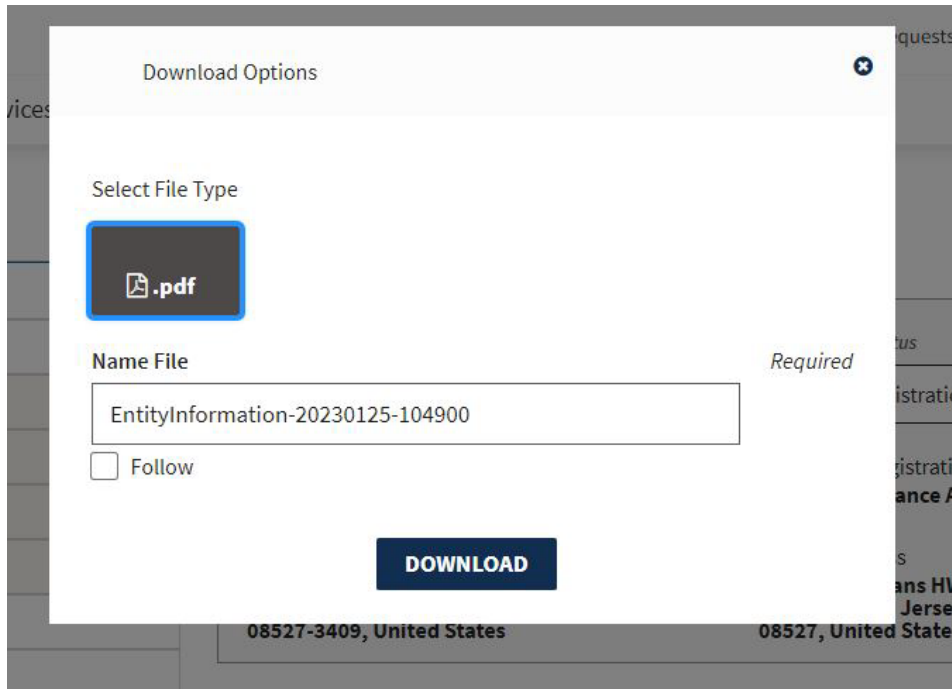
